Risk and benefits

This information is expected to help the policy makers to improve the life circumstances of people. Your refusal to give interview will in no way affect the services you and your family receive or will receive.

Privacy, anonymity and confidentiality

I want to assure you that all of your answers and your name and address will be kept strictly confidential. Your name will not appear on the interview or on any documents based on the study. The interviews will be kept in a locked cabinet and used only for research purpose.

Future use of information

Your response and those of approximately 2000 other men will give us an understanding of men's roles in society today, information that could be useful in making Bangladesh a healthier and better place.

It is important to emphasize that the laws in your country make it a crime to use physical violence against women, or to have sex with someone under age 18, and to force a woman to have sex with you.

If there are any of these issues discussed that you would like more information, such as where to go for health services in your community, we have prepared a list of such services which you will be given by the interviewer.
